Webmaster help – as noted in Bill Cobb's Webmaster Report, and recognized for some time, help is needed for routine posting to the website, as well as for an overall website upgrade. Bill would remain the webmaster with overall control, but directors were asked to assist in finding the right person(s) to help.

The Matt Walter Fund – Keith advised a few years ago Mr. Walter donated funds to the FFLA to use for tower projects, preferably in the northeast, and noted that there could likely be more for other appropriate projects. Gary will put together the criteria for applying for grants from the fund. This is totally separate from the FFLA Restoration Grant program.

Conference Guide – Sam Duffey is working on a guide for putting on a conference, with the goal of making it a less onerous task and increasing the willingness of directors and others to host one. She is soliciting input from past and current conference hosts.

Conferences – Laurie Rankin announced that she will be hosting a Northeastern Conference June 8-9 in the Catskills of New York. Scott McClintock announced that the Southern California chapter will be hosting the Western Conference October 11-13 in Escondido, California.

Recruitment of Directors – Sam brought up recruitment of directors and what their job entails. Keith noted that he had relied on outgoing directors to advise the incoming director of the job

duties. Sam asked for anyone with ideas on new director recruitment to email her with those ideas
